 SERVICES AND SHALL CARRY ALL MANDATED INSURANCE AND LIMITS THROUGHOUT THE
 TERM OF THIS AGREEMENT.
- III. RODENT EXCLUSION GUARANTEE CARRIES A ONE YEAR WARRANTY. IF INITIAL EXCLUSION FAILS SOUTHEAST WILL RE-INSPECT AND REPAIR AT NO ADDITIONAL CHARGE. IF STRUCTURE SHOULD BECOME RE-INFESTED SOUTHEAST WILL RENDER ALL TREATMENT AND EXCLUSION NEEDED AT NO ADDITIONAL COST WHILE UNDER ONE YEAR GUARANTEE. GUARANTEE DOES NOT COVER ANY DAMAGE TO PROPERTY OR ITS BELONGINGS DUE TO RODENT INFESTATION. GUARANTEE DOES NOT COVER ANY ADDITIONAL WORK BEYOND ORIGINAL SCOPE OF WORK.

A MONTHLY PEST CONTROL SPRAYING TO ALL LAWN AND SHRUBS FOR EACH OF THE 224 HOMES. TREATMENT IS FOR ANTS, COCKROACHES, MILLIPEDES, AND OTHER OCCASIONAL INSECTS COMMON TO SOUTH FLORIDA. TREATMENT DOES NOT COVER ANY INSECTS INSIDE HOMES.

B. RODENT BAITING
